

FOGHUB PRIVACY POLICY

Protecting your private information is our priority. This Statement of Privacy applies to foghub.io, as well as all of its subdomains, and Foghub and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Foghub include foghub.io, and all Foghub.io subdomains, as well as all Foghub software. The Foghub website is a software products company site. By using the Foghub website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Foghub may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number
- Employer
- Job Title

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) sending us an email message. We will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Foghub collects and uses your personal information to operate its website(s) and deliver the services you have requested. Foghub may also use your personally identifiable information to inform you of other products or services available from Foghub and its partners.

Sharing Information with Third Parties

Foghub does not sell, rent or lease its customer lists to third parties. Foghub may share data with trusted partners to help perform statistical analysis, send you email or postal mail, or provide customer support. All such third parties are prohibited from using your personal information except to provide these services to Foghub, and they are required to maintain the confidentiality of your information.

Foghub may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Foghub or the site; (b) protect and defend the rights or property of Foghub; and/or (c) act under exigent circumstances to protect the personal safety of users of Foghub, or the public.

Tracking User Behavior

Foghub may keep track of the websites and pages our users visit within Foghub.io, in order to determine what Foghub services are the most popular. This data is used to deliver customized content and advertising within Foghub to customers whose behavior indicates that they are interested in a particular subject area.

Foghub application software may track feature usage in order to determine what features of the software are most popular. This data is used to prioritize enhancements to Foghub software and identify areas that can be improved.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Foghub. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Foghub website.

Use of Cookies

The Foghub website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Foghub pages, or register with Foghub site or services, a cookie helps Foghub to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Foghub website, the information you previously provided can be retrieved, so you can easily use the Foghub features that you customized.
